GIBA ANNUAL PASS Vehicle Eligibility: Only cars and pick-up trucks are eligible for an annual pass. Dual wheel pick-up trucks, RV's, commercial trucks, and trailers are not eligible for the annual pass. The annual pass allows the user to pay one fee, in advance, for 12 months of use. This fee allows the vehicle driver to make unlimited round trips for the one-year term. The cost of an annual pass is \$780.00 plus the cost of the sticker. This option is one sticker, one car, one year, and requires the sticker to be affixed to the vehicle. NO EXCEPTIONS ANNUAL PASS TERMS AND CONDITIONS I understand that if I do not permanently attach the Annual Pass decal to ONE vehicle, or if I circumvent this policy by any means, I will forfeit the privileges to use the GIBA Annual Pass program, my account will be cancelled, and any funds remaining will be forfeited to the Gasparilla Island Bridge Authority.
